## 1 Introduction

---

This document describes all prices relating to open eir's<sup>1</sup> ADSL / ADSL 2plus Bitstream Service and Bitstream Backhaul Service and Next Generation Services.

## 2 ADSL Bitstream Charges

The price for open eir's ADSL / ADSL 2plus Bitstream Service is made up of a number of elements:

- Service Establishment Charge
- Port Connection
- Port Rental
- Cessation (per port)
- Transfer (per port)
- Upgrade/Downgrade (per port)
- Aggregate usage charge (Bitstream Managed Backhaul only)
- Promotional Offers (covered in section 5)

Any changes to these prices are exempt from the requirements of Clause 10 of the open eir's Bitstream Access Reference Offer (BARO) and the open eir's Bitstream Reference Offer Minimum Term (BARO MT) and do not constitute Amendments as defined in Clause 10 of the open eir BARO and the open eir BARO MT.

Prices are effective from the date indicated on this Price List. Where applicable tables indicate the time frames for which a charge is valid with "effective from" and "effective to" dates shown. This open eir Bitstream Price List will be updated and republished from time to time. Operators will be notified when changes are made to the Bitstream Price published on open eir's website.

In the event that the termination of a Backhaul is required, the Operator shall give to open eir in writing at least one month's notice, expiring on the last day of the calendar month following that in which the notice is given. Where such a termination request takes effect prior to the expiry of the minimum period of service, then the Operator shall be liable for all charges for the remaining portion of the minimum period. Where notice is given which expires after the minimum period of service, charging shall cease on the last day of the notice period.

Where the Operator requests a Migration and such request is delivered, a new minimum period will apply to the product to which the Migration is made. If the Migration request takes effect prior to the expiry of the minimum period of the Backhaul circuit, the charges shall be waived.

### 3.4 Other Charges

#### 3.4.1 Fault Related Charges

This regime will apply until such a time that Operators can order an in situ NGA service at a premises that has an NTU already installed through previous NGA installations. An order for an in situ service in this case means that an Operator can place an NGA order without the need to create an appointment for an end-user visit to install the NTU.

(9) In the scenario where an NGA order is completed that includes a request for the installation of an NTU and open eir's records show that an NTU had previously been installed by open eir as part of a non-insitu SB-WLR order (LNN Order) completed within the previous 30 days, the NTU connection charge will be rebated. This regime will apply until such a time that Operators can submit a combined order for non-insitu SB-WLR and NGA Bitstream/VUA.

(10) This charge applies when an FTTH ONT is installed by open eir for both POTS Based NGA services and Standalone NGA services. Service Connection is the installation of an ONT at the customer's premises to deliver a new FTTH Service. Migration is the transfer of an active FTTH service from one Operator to another. Service Activation applies where the customers' premises have previously had an ONT installed to deliver FTTH Service but that service is not currently active. Service Activation may be electronically activated or may require an engineer visit to activate the service.

(11) This charge applies when an Operator changes a port within the same NGA product set and where the port is assigned to the same Operator before and after the change. This may be from one FTTC profile to another FTTC profile or from one FTTH product to another FTTH product. For the avoidance of doubt, changes between NGA product sets, e.g. FTTC to FTTH are not considered upgrades or downgrades. Where an Operator changes a port from FTTC to FTTH, this is considered a Service Connection, as described in note (10), and Service Connection charges will apply. Where an Operator changes a port from FTTH to FTTC, Connections charges, as described in Notes (1), (2), (3), (4) and (5) above, will apply.

Note 1: A charge of €30 will be applied for a missed appointment that is the result of a customer generated issue as defined in the NGA IPM. This charge will apply for an initial period of 90 days post launch and will be reviewed thereafter.

Note 2: No charge will be applied when an underground ducting blockage is discovered on the first visit to an end user's premises as part of an FTTH provision. However, if an Operator subsequently requests the order to be completed on the basis that the blockage has been cleared and it is discovered by open eir that the blockage is still in place a €30 charge will apply.

#### 4.1.5 NGA Bitstream Plus Usage - Monthly Charge

The Usage Charge is based on 95th Percentile Billing and is aggregated across all ports attached to Bitstream Plus product per Operator.

The traffic classes are Standard (ST), Assured Forwarding (AF) and Expedited Forwarding (EF).

Total NGA Usage = Monthly Port Usage Charge \* Active NGA Ports

(1) Monthly Port Usage Charge =  $0.9 * \text{LN}[\text{"Avg Port Usage" in kbps minus 200}]$

(2) Active NGA Ports - The number of "Active NGA Ports" that an Operator has. Note: The "Active NGA Ports" will be taken on the day, closest to the 95<sup>th</sup> percentile reading, on which the active ports are recorded. (The volume of active ports is recorded on 4 separate days a week.)

An outline of the usage model to derive the monthly usage charge is provided below:

1. The traffic is measured every 15 minutes over the course of a month.
2. The traffic measurements at each 15 minute interval on each BPU circuit are as follows:

Downstream ST Traffic	Upstream ST Traffic
Downstream AF Traffic	Upstream AF Traffic
Downstream EF Traffic	Upstream EF Traffic

3. For this set of values – the higher of the two ST readings, the higher of the two AF readings and the higher of the two EF readings are chosen e.g. HIGH ST value; HIGH AF value and HIGH EF value are identified (BPU set of values)

4. Therefore, over the course of a month each BPU circuit will have these 3 values recorded every 15 minutes.
5. The Factored 95<sup>th</sup> Percentile Usage can be calculated at the end of the month as follows:
  - a. The set of BPU Values at each 15 minutes interval are plugged into the formula:  

$$\text{BPU Usage @ 15 interval} = [\text{HIGH ST} * 1 + \text{HIGH AF} * 1.25 + \text{HIGH EF} * 1.5]$$
  - b. The “BPU Usage @ 15 min interval” for all circuits is then added together to get the “BPU Aggregate Usage @ 15 interval”.
  - c. The values at each 15 minute interval for the “BPU Aggregate Usage @ 15 min interval” are then sorted from highest to lowest with the highest 5% of values removed to obtain the “Factored 95<sup>th</sup> Percentile Usage”
6. The date and time of the “BPU Aggregate Usage @ 15 min interval” that turns out to be the “Factored 95<sup>th</sup> Percentile Usage” is identified and recorded.
7. The number of “Active NGA Ports” that Operator has on the date and time of the “Factored 95<sup>th</sup> Percentile Usage” are identified.
8. The “Avg Port Usage” is calculated by dividing “Factored 95<sup>th</sup> Percentile Usage” by “Active NGA Ports” and rounded up to the nearest increment of 25kbps.
9. The “Monthly Port Usage Charge” is calculated using the following formula:  

$$\text{Monthly Port Usage Charge} = 0.9 * \text{LN}[\text{“Avg Port Usage” in kbps minus 200}]$$
10. Therefore, Total NGA Usage = Monthly Port Usage Charge \* Active NGA Ports.

#### 4.1.5.1 NGA Regional Handover Discount

---

This section outlines a mechanism for Operators to obtain a discount for traffic handled regionally, including details of the qualifying criteria that Operators must meet to avail of the discount.

##### Qualifying Criteria:

An Operator can avail of a Regional Handover discount if the following criteria are met:

- a. An Operator must have BPUs handed off via a qualifying WEIL. Qualifying WEILs are those co-located at the exchanges for each region listed in the table below or an Operator Edge Node Handover WEIL (ENH Node) within a region.
- b. A BPU from an exchange handed off via WEIL in the same area is designated a “Same Area BPU”.
- c. In order to qualify for the Regional Handover discount all Operator Same Area BPU traffic must be handed off on qualifying WEILs within the associated Region



- d. If the criteria above are not fulfilled by the Operator for any Region then the Operator will forfeit the Regional Handover discount in its entirety across all Regions for that month.
- e. An Operator must opt in to this offer in order to avail of the Regional Handover discount by notifying their designated Account Manager. Operators must specify at least 30 days prior to the commencement of a billing period for usage that they now wish to avail of the discount. The billing period for NGA Usage commences on the 1<sup>st</sup> of each month.

**Regional WCA<sup>15</sup> - Summary of Regional Handover Calculation:**

- The Bitstream Plus Usage per user (in kbps) will be calculated as per the methodology defined in the prevailing Bitstream Price List. This value will be applied against the formula in the Bitstream Price list to obtain the port usage charge per month “Port Usage Charge”.
- Operators that do qualify for a discount will have the discount applied against the “Port Usage Charge” as follows:
  - Discounted Port Usage Charge = Port Usage Charge \* (1 - R \* X)
  - where R is the ratio of all Operator Regional NGA Traffic to Total Operator NGA Traffic
  - where X = the maximum discount parameter listed in the table below.

1. The Bitstream Plus Usage per user (in kbps) will be calculated as per the methodology defined in the prevailing Bitstream Price List. This value will be applied against the formula in the Bitstream Price list to obtain the port usage charge per month “Port Usage Charge”.
2. Operators that do qualify for a discount will have the discount applied against the “Port Usage Charge” as follows:
  - Discounted Port Usage Charge = Port Usage Charge \* (1 - R \* X)

## Appendix A: Bitstream MB Additional Details

---

For the Bitstream Managed Backhaul (Bitstream MB) product a new VLAN is required on the Bitstream (Ethernet) Connection Service to carry the Bitstream MB traffic separately to the existing Bitstream IP traffic.

The Operator will be billed for the amount of capacity that they use on this dedicated VLAN over their BECS connection using the 95th percentile usage based model. This is in addition to the fixed charge per DSL port.

95th Percentile Billing is a standard way in which bandwidth is billed by ISP's. Typically it means that samples are taken every 5 minutes for a month and the top 5% are discarded. This allows the Operator to have short periods (less than 36 hours total for the month) where higher than normal bursts in traffic do not count against the amount being charged.

The 8Mb and 24Mb Bitstream MB traffic will use the same VLAN and the usage will be based on an aggregate figure using the existing calculation.

The Usage will be included on the Backhaul Bill which will be changed from quarterly to monthly billings. The existing Backhaul charges will still only be applied on a quarterly basis.
